What is the purpose of this update?

This document tells you how the Lifestages Australasian Equity Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. Funds Administration New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to achieve capital growth and returns over the long-term through investing primarily in a broad spread of New Zealand and Australian equities. The fund offers a multimanager approach to equity investing.

What are the risks of investing?

Risk indicator for the Lifestages Australasian Equity Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

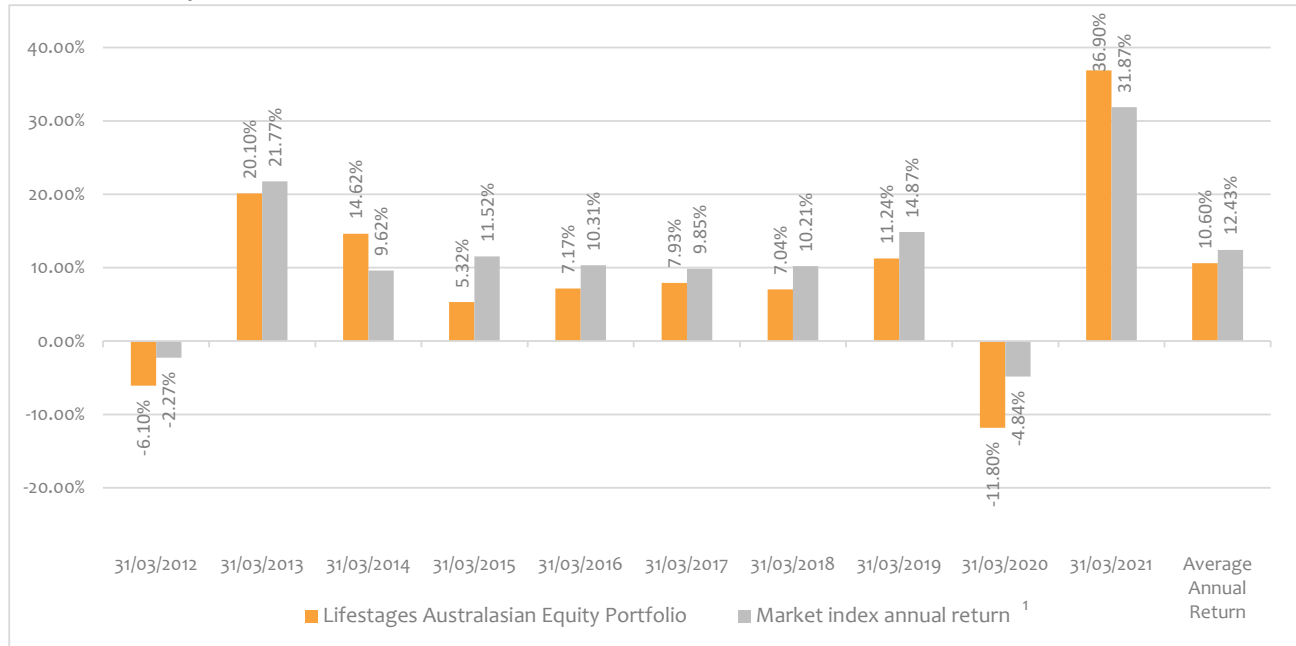
How has the fund performed?

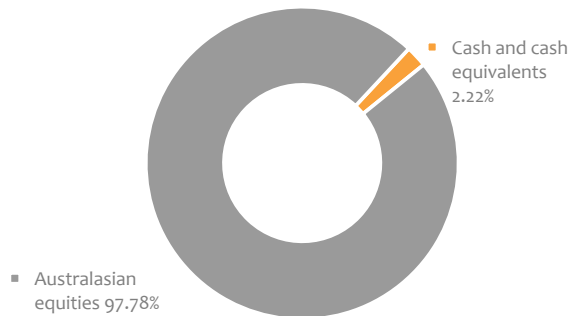
Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$1,949 (that is 19.49% of her initial \$10,000). This gives Hayley a total return after tax of \$1,901.00 for the year.

The top 10 investments make up 101.20% of the net asset value of the fund.

Currency hedging

As at 30 September 2021 the fund has an exposure to foreign currency assets of 31.80%, of which 0.00% was hedged back to NZD. This means the fund's foreign currency exposure is 31.80%.
